As voted on by the league coaches and approved by the board, the following consequences have been put into place as of January 13, 2019 and will remain in effect until further notice. This policy will become active as of the February 17, 2019 meeting. All head coaches are to be held accountable with this policy starting with the February 17, 2019 meeting. The head coaches/team representatives that missed the January 13, 2019 meeting will not be held responsible for this policy due to the fact this was not presented and approved until that meeting, but they will be responsible for any information that was missed and information needed by the division supervisors.

The policy is as follows:

Head Coach/team representative missing one meeting: head coach will need to take the following course, https://nfhslearn.com/courses/13000/coaching-softball and be responsible for the \$50 fee. The head coach will also have his practice slot restricted and the team will not be allowed to practice until the completion certificate is presented to the division supervisor and league director. The deadline for completion is April 15 of the current year if not done so, the head coach will be suspended and a new head coach will be assigned to the team so not to punish the team for the coaches reluctance to adhere to this policy.

Head Coach/team representative missing two meetings: head coach will be suspended for the entirety of the current season, will need to complete the course, show the completion certificate and will require reinstatement by the board for the following season. A new head coach will be assigned to that team as head coach for the current season and a decision will be made by the board as to who will be the head coach for the following season.
